## 3 SEC. 1. SHORT TITLE.

- 4 This Act may be cited as the "Register of Copyrights
- 5 Selection and Accountability Act of 2017".

## 6 SECTION 2. REGISTER OF COPYRIGHTS.

- 7 (a) AMENDMENTS.—Section 701 of title 17, United
- 8 States Code, is amended—

1	(1) in subsection (a)—
2	(A) by striking "(a) All administrative"
3	and inserting the following:
4	"(a) Register and Director.—
5	"(1) IN GENERAL.—All administrative";
6	(B) by striking "director" and inserting
7	"Director";
8	(C) by inserting after the first sentence the
9	following: "The Register of Copyrights shall be
10	a citizen of the United States with a profes-
11	sional background and experience in copyright
12	law and shall be appointed by the President, by
13	and with the advice and consent of the Sen-
14	ate."; and
15	(D) in the last sentence, by striking "shall
16	be appointed" and all that follows through "and
17	shall act" and inserting "shall act";
18	(2) in subsection (b), by redesignating para-
19	graphs $(1)$ through $(5)$ as subparagraphs $(A)$
20	through (E), respectively, and adjusting the margins
21	accordingly;
22	(3) by redesignating subsection (b) as para-
23	graph (2), and adjusting the margins accordingly;
24	(4) in paragraph (2), as so redesignated, by in-
25	serting "DUTIES.—" before "In addition";

1	(5) by inserting after paragraph $(2)$ the fol-
2	lowing:
3	"(3) OATH.—The Register of Copyrights shall,
4	before taking office, take an oath to discharge faith-
5	fully the duties of the Copyright Office described in
6	paragraph (2).
7	"(4) Removal.—
8	"(A) IN GENERAL.—The Register of Copy-
9	rights may be removed from office by the Presi-
10	dent.
11	"(B) NOTIFICATION.—The President shall
12	provide notification to both Houses of Congress
13	of a removal under subparagraph (A).
14	"(5) TERM OF OFFICE.—
15	"(A) IN GENERAL.—Subject to subpara-
16	graph (B), the Register of Copyrights—
17	"(i) shall be appointed for a term of
18	10 years; and
19	"(ii) may serve until a successor is ap-
20	pointed, confirmed, and taken the oath of
21	office.
22	"(B) LIMITATION.—The Register of Copy-
23	rights may not continue to serve after the date
24	on which Congress adjourns sine die after the

1	date on which the 10-year period described in
2	subparagraph (A)(i) ends.
3	"(C) REAPPOINTMENT.—An individual ap-
4	pointed to the position of Register of Copy-
5	rights, by and with the advice and consent of
6	the Senate, may be reappointed to that position
7	in accordance with the requirements of this sec-
8	tion.";
9	(6) by redesignating subsections (c) through (f)
10	as subsections (b) through (e), respectively;
11	(7) in subsection (b), as so redesignated, by in-
12	serting "SEAL.—" before "The Register";
13	(8) in subsection (c), as so redesignated, by in-
14	serting "ANNUAL REPORT.—" before "The Reg-
15	ister'';
16	(9) in subsection (d), as so redesignated, by in-
17	serting "Applicability of Title 5.—" before
18	"Except as provided"; and
19	(10) in subsection (e), as so redesignated, by
20	inserting "Compensation.—" before "The Reg-
21	ister".
22	(b) APPLICABILITY.—The amendments made by sub-
23	section (a) shall apply with respect to any vacancy for the
24	Register of Copyrights after January 1, 2017. If a Reg-
25	ister of Copyrights is appointed during the period begin-

ning on January 1, 2017 and ending on the day before
the date of the enactment of this Act, that Register shall
meet the requirements of the amendments made by this
Act or shall be replaced in accordance with such amend ments.
