Dear Secretary Mayorkas:

The Committee on the Judiciary continues to conduct oversight of the Biden Administration's enforcement of federal immigration law. The Committee previously wrote to the Department of Homeland Security (DHS) for various documents and information, including the production of alien files (A-files) and related immigration case information for several alleged criminal illegal aliens. However, to date, DHS has failed to comply with the Committee's requests.

#### Daniel Hernandez-Martinez

On October 30, 2023, the Committee requested<sup>1</sup> the A-file and related immigration case information for Daniel Hernandez Martinez, a Venezuelan national, who "randomly attacked at least three strangers and two cops and gotten arrested—and released—six times on 14 different charges" within just two months of his arrival in New York City.<sup>2</sup> The deadline for production lapsed on November 13, 2023, nearly five months ago. Committee staff followed up with DHS on November 13<sup>3</sup> and January 25;<sup>4</sup> however, to date, DHS has not produced the A-file.

#### Roberto Emilio Vasquez-Santamaria

On October 30, 2023, the Committee requested<sup>5</sup> the A-file and related immigration case information for Roberto Emilio Vasquez-Santamaria, a national of Peru, following reports that Texas Rangers arrested the alien for an alleged murder.<sup>6</sup> Vasquez-Santamaria is accused of "bludgeon[ing] [the victim] to death in the backyard of a home." According to press reports, Vasquez-Santamaria entered the U.S. illegally and was released to a non-governmental shelter in Eagle Pass, Texas, on May 9, 2023. Although the production deadline lapsed nearly five months ago and the Committee has followed up with DHS about its request, DHS has not produced the A-file.

#### Pierre Lucard Emile

On January 24, 2024, the Committee requested <sup>10</sup> the A-file and related immigration case information for Pierre Lucard Emile, a Haitian national, after police in Boston, Massachusetts, arrested the alien in connection with a vicious "assault and battery on a developmentally disabled person." According to U.S. Immigration and Customs Enforcement (ICE), Emile initially entered the United States through the Brownsville, Texas, port of entry in December 2022, "where he was deemed inadmissible," yet DHS released him after he was "issued a notice to appear before an immigration judge . . . in Boston." The production deadline for the A-file lapsed on February 7, more than two months ago. Despite the Committee following up on its request, <sup>14</sup> DHS has failed to produce the A-file.

#### Alleged Assaulters of New York City Police Officers

On February 7, 2024, the Committee requested the A-files and related immigration case information for a group of so-called "asylum seekers" who brutally attacked two New York City

police officers near a migrant shelter in Times Square. <sup>15</sup> According to media reports, those arrested and charged in the attack include Darwin Andres Gomez-Izquiel, Kelvin Servat Arocha, Juarez Wilson, Jhoan Boada, Yorman Reveron, Yohenry Brito, and Jandry Barros. <sup>16</sup> Due to New York City's radical, soft-on-crime policies, several of the reported attackers were subsequently released "without monetary bail." <sup>17</sup> After being released from custody, four of the accused attackers reportedly fled New York. <sup>18</sup> According to press reports, "the four provided phony names to a nonprofit group working with the city on migrant issues before boarding [a California-bound] bus." <sup>19</sup> The production deadline lapsed nearly two months ago. To date, DHS has failed to produce the A-files.

#### Bechir Lehbeib

On February 7, 2024, the Committee requested<sup>20</sup> the A-file and related immigration case information for Bechir Lehbeib, a 26-year-old "Palestinian migrant," who, according to press reports, was arrested by Nassau County police after he "stole a homeowner's U.S. and Israeli flags out of his yard and then beat the man to the ground while yelling antisemitic slurs." Lehbeib was charged with "hate crime assault, robbery[,] and criminal mischief." Authorities believe that Lehbeib "entered the U.S. at the Mexican border in Arizona over the summer and claimed to be seeking asylum." While the deadline for production lapsed more than a month ago, to date, DHS has not produced the A-file.

#### Alleged Attackers in Vicious Chicago Train Robbery

On March 1, 2024, the Committee requested<sup>24</sup> the A-files and related immigration case information for four Venezuelan nationals after they were arrested by Chicago police officers for "lur[ing] a man to the back of a CTA train car and chok[ing] him into unconsciousness during a

vicious robbery."<sup>25</sup> The four men, Carlos Carreno-Carreno, Wilker Gutierrez Sierra, Yonnier Guasamucare-Garcia, and Fernando Loyo-Rodriguez, were "charged with robbery and aggravated battery by strangulation."<sup>26</sup> Press reports indicate that Carreno-Carreno, Loyo-Rodriguez, and Guasamucare-Garcia entered the U.S. just months ago and that they "were on pretrial release" resulting from previous arrests involving retail theft.<sup>27</sup> Although the deadline for production lapsed on March 14, to date, DHS has failed to produce the A-files.

#### Renzo Mendoza Montes

On March 1, 2024, the Committee requested<sup>28</sup> the A-file and related immigration case information for Renzo Mendoza Montes, "a 32-year-old Venezuelan national," arrested by police in Campbell County, Virginia, for the brutal assault of a 14-year-old girl.<sup>29</sup> Authorities state that Mendoza Montes was "previously detained and released by U.S. Customs and Border [Protection] in El Paso, Texas, on September 2, 2023." The production deadline lapsed nearly a month ago; however, DHS has not produced the A-file.

#### Angel Matias Castellanos-Orellana

On March 14, 2024, the Committee requested<sup>31</sup> the A-file and related immigration case information for Angel Matias Castellanos-Orellana, a 19-year-old Honduran national, arrested by police in Kenner, Louisiana, for the brutal assault of a 14-year-old girl and the "repeat[ed] stabbing [of] [a] man during a robbery."<sup>32</sup> Castellanos-Orellana "was charged with armed robbery, aggravated battery, first-degree rape, and aggravated assault."<sup>33</sup> According to authorities, Castellanos-Orellana, an illegal alien, "entered the U.S. in Eagle Pass, Texas on October 6, 2023."<sup>34</sup> While the production deadline lapsed on March 28, 2024, DHS has failed to produce the requested materials.

#### Carlos Obed Yepez-Bedoya

On March 14, 2024, the Committee requested<sup>35</sup> the A-file and related immigration case information for Carlos Obed Yepez-Bedoya, a 40-year-old Colombian national found to be a "positive match' with the terror watchlist." According to press reports, Yepez-Bedoya "illegally cross[ed]" the southwest border and "was flagged as a 'group member,' indicating [his] associat[ion] with a terror organization." Although the production deadline lapsed in March, DHS has not produced the A-file.

#### Argenis and Diego Ibarra

On March 18, 2024, the Committee requested the A-file and related immigration case information for Argenis and Diego Ibarra, Venezuelan nationals and relatives of the illegal alien charged with murdering 22-year-old nursing student Laken Riley. Press reports indicate the brothers entered the U.S. in April 2023. Although Diego Ibarra had Tren de Aragua gangaffiliated tattoos on his body and "agents from Homeland Security Investigations found social media accounts where Ibarra flashed gang[] hand signals," the Biden Administration released Diego Ibarra and "placed [him] in [an] Alternatives to Detention program (ATD)." On "May 25, 2023, Ibarra was removed from the ATD program" after it was discovered that he "cut off his ankle monitor," which "was located on the side of the road in Littleton, Colorado." Since coming to the U.S., both brothers have had run-ins with the law relating to their possession of fraudulent immigration documents. In addition, Diego Ibarra has been connected to a domestic dispute and was arrested for driving under the influence and shoplifting. The production deadline for the Ibarra brothers' A-files lapsed on April 1, 2024, but DHS has not produced the requested materials.

#### Cory Alvarez

On March 19, 2024, the Committee requested the A-file and related immigration case information for Cory Alvarez, a 26-year-old Haitian national arrested by Rockland, Massachusetts, police in connection with a vicious assault on a disabled 15-year-old girl. According to press reports, in June 2023, Alvarez was flown "directly from Haiti to John F. Kennedy Airport in New York City" as part of the Biden Administration's illegal categorical parole program known as CHNV that "allows up to 30,000 Cubans, Haitians, Nicaraguans, and Venezuelans to fly into the U.S." each month. The deadline for production of the requested materials lapsed on April 2, 2024, but DHS has failed to produce the A-file.

#### Awet Hagos

On March 26, 2024, the Committee requested<sup>50</sup> the A-file and related immigration case information for Awet Hagos, a 32-year-old Eritrean national who "entered the U.S. illegally after residing in Haiti and had been living in North Carolina for the last six months." The Gates County Sherriff's Office in North Carolina, responding to reports of gunfire, "attempted to take Hagos into custody." However, the alien "became 'extremely combative[,]' [] attempted to disarm a deputy of their firearm, . . . fled into his home[,] and led police on a four-hour standoff." Hagos was "charged with three counts of assault on a government official, three counts of resisting a public officer, and one count of carrying a concealed weapon." After the arrest, authorities ran Hagos's fingerprints and "allegedly found that he was on the terrorist watch list." The Committee requested DHS produce the A-file by April 9, 2024, but to date, the materials have not been provided.

#### Jose Barrera

On March 26, 2024, the Committee requested<sup>56</sup> the A-file and related immigration case information for Jose Barrera, after police in O'Fallon, Missouri, arrested him in connection with the brutal stabbing of "his neighbor and the neighbor's brother" at a laundromat.<sup>57</sup> According to authorities, Barrera "entered the U.S. illegally through Eagle Pass, Texas, in 2021." Although the deadline for production lapsed on April 9, 2024, DHS has not produced the A-file.

DHS's failure to provide the Committee with the requested documents is unacceptable and prevents the Committee from fulfilling its constitutional oversight obligations. Accordingly, please provide the documents and information requested in the Committee's October 30, January 24, February 7, March 1, March 14, March 18, March 19, and March 26 letters (enclosed herein for your convenience) as soon as possible, but no later than 5:00 p.m. on April 25, 2024. The Committee may be forced to resort to compulsory process if these requests remain outstanding.

The Committee is authorized to conduct oversight of federal immigration law pursuant to the Rules of the House of Representatives.<sup>59</sup> If you have any questions, please contact Committee staff at (202) 225-6906. Thank you for your prompt attention to this matter.

Dear Secretary Mayorkas:

According to press reports, Daniel Hernandez Martinez, a Venezuelan national, "has randomly attacked at least three strangers and two cops, and gotten arrested—and released—six times on 14 different charges" since arriving in New York City only two months ago. In addition to a string of petty thefts, including "using a large metal pipe to break locks to steal bicycles in Times Square," Martinez is alleged to have threatened and assaulted multiple people, including hitting a man with a bike tire, kicking a woman and dragging her by her hair, threatening another person with a chain, and pulling "out a large knife and advanc[ing] toward an undercover officer."

Criminal aliens exploit vulnerabilities in our nation's immigration system to the detriment of those in the United States. According to press reports, "the four provided phony names to a nonprofit group working with the city on migrant issues before boarding [a California-bound] bus."

On February 27, 2024, we wrote to you requesting information and documents regarding Jose Antonio Ibarra, the 26-year-old illegal alien from Venezuela, who allegedly murdered Laken Riley, a 22-year-old Augusta University nursing student, on February 22, 2024. According to Immigration and Customs Enforcement (ICE), the Biden Administration released Ibarra into the United States in 2022 after he "entered the U.S. illegally from Venezuela," paroling him into the country<sup>4</sup> despite his reported affiliation with the dangerous Tren de Aragua gang.<sup>5</sup>

We now write to request the same information and documents regarding Ibarra's brothers, Diego and Argenis Ibarra. According to ICE, both brothers entered the United States illegally

near Eagle Pass, Texas, on April 3, 2023.<sup>6</sup> They were expelled by Border Patrol agents pursuant to Title 42 authorities but re-entered the country illegally on April 30, 2023.<sup>7</sup> Despite attempting to bite a Border Patrol agent, Diego Ibarra was subsequently released on Alternatives to Detention (ATD) by ICE.<sup>8</sup> Argenis Ibarra was released by ICE with a notice to appear in immigration court.<sup>9</sup>

Since his release, Diego Ibarra's interactions with U.S. law enforcement officials reportedly include arrests for "failure to appear for a fingerprintable offense," driving under the influence, "speeding, failure to yield to an emergency vehicle, possession of an open container of alcohol, [] driving without a license," shoplifting, 11 as well as a visit from police during which Diego Ibarra was accused of slapping his girlfriend in the face. 12 According to authorities, Diego Ibarra, like his brother Jose, "appears to be affiliated with the Tren de Aragua gang." He was most recently arrested as police in Athens-Clarke County, Georgia, were searching for Riley's murderer, after he produced a fake green card when asked for identification. Argenis Ibarra was encountered by ICE on February 23, 2024, in Athens, Georgia, while ICE was "assisting the University of Georgia Police Department with their investigation into the murder of Laken Riley."

On March 11, 2024, the Gates County Sheriff's Office in North Carolina "responded to reports of gunfire" at a gas station and subsequently arrested Awet Hagos, a 32-year-old Eritrean national who "entered the U.S. illegally after residing in Haiti and had been living in North Carolina for the last six months." When authorities "attempted to take Hagos into custody, [] he became 'extremely combative[,]' [] attempted to disarm a deputy of their firearm," and "fled into his home and led police on a four-hour standoff." Hagos was "charged with three counts of assault on a government official, three counts of resisting a public officer, and one count of carrying a concealed weapon." After the arrest, authorities ran Hagos's fingerprints and "allegedly found that he was on the terrorist watch list."
