Dear Attorney General Garland:

On September 25, 2024, the Committee wrote to you requesting documents relating to the Department's public release of a letter in which the man who sought to assassinate President Donald J. Trump in Florida on September 15, 2024, offered a \$150,000 bounty on President Trump.<sup>1</sup> Despite the Committee's attempts to follow up with Department staff, to date, you have failed to comply with our requests. We write to reiterate our September 25 requests and ask for your voluntary cooperation with our oversight.

As we previously noted, the Department's decision to broadcast the attempted assassin's bounty on President Trump seems to contravene the Department's stated policy that the release of "legacy tokens," more commonly known as manifestos, "will contribute to further attacks" by "spark[ing] incredibly intense interest and study."<sup>2</sup> This deviation from protocol raises significant concerns, particularly in the context of the Department's ongoing, aggressive, and unconstitutional<sup>3</sup> prosecution of President Trump.

Accordingly, the Committee reiterates its request from its September 25, 2024 letter which is enclosed and incorporated herein. We ask that you produce the requested documents and communications immediately, but not later than 10:00 a.m. on November 12, 2024. The Committee is prepared to resort to compulsory process to obtain compliance with our requests.

Dear Attorney General Garland:

The Committee on the Judiciary continues to conduct oversight of political bias and politicization within the Department of Justice. During your tenure as Attorney General, the Department has generally refused to release details about so-called "manifestos" written by the perpetrators of high-profile crimes.<sup>1</sup> Yet, earlier this week, in a public court filing, the Department released a letter in which the man who sought to assassinate President Donald J. Trump in Florida on September 15, 2024, offered a \$150,000 bounty on President Trump.<sup>2</sup> This decision seems to contravene the Department's stated policy that "public access to legacy tokens," more commonly known as manifestos, "will contribute to further attacks" by "spark[ing] incredibly intense interest and study" by potential copycat offenders and providing a blueprint for future attackers.<sup>3</sup>

The Department's decision to broadcast the attempted assassin's bounty on President Trump—at the same time that the Department is aggressively and unconstitutionally<sup>4</sup> prosecuting President Trump—raises significant concern that the Department could cause additional harm to occur. To further the Committee's ongoing oversight to ensure that the Justice Department is upholding its standard of impartiality, we request the following documents:

1. All documents and communications referring or relating to the FBI's May 2023 "Protection of Legacy Tokens" memorandum; and

> 2. All documents and communications referring or relating to the release of the wouldbe assassin's letter to "The World" as part of the Department's Written Factual Proffer in Support of Pretrial Detention filed on September 23, 2024.

We respectfully ask that you produce these documents and communications as soon as possible, but no later than 5:00 p.m. on October 9, 2024. Pursuant to the Rules of the House of Representatives, the Committee has jurisdiction to conduct oversight over the Department of Justice.<sup>5</sup>
