

**AMENDMENT IN THE NATURE OF A SUBSTITUTE**  
**TO H.R. 98**  
**OFFERED BY M**\_\_ . \_\_\_\_\_

Strike all that follows after the enacting clause and  
insert the following:

**1 SECTION 1. SHORT TITLE.**

2       This Act may be cited as the “End Endless Criminal  
3 Statutes Act of 2025”.

**4 SEC. 2. FINDINGS.**

5       Congress finds that actions which may unnecessarily  
6 carry criminal penalties under Federal statutes include the  
7 following:

8           (1) Writing a check for less than \$1.

9           (2) Selling or possessing colored oleomargarine  
10       or colored margarine unless they are packaged and  
11       labeled or served in a triangular shape.

12          (3) Discarding produce without sufficient cause  
13       or making a false report concerning that produce.

14          (4) Removing a stamp from any mail matter.

15          (5) Making metal coins of original design or at-  
16       tempting to use such coins.

17          (6) Wearing the uniform of letter carriers of  
18       the Postal Service.

1 (7) Detaining a seaman's clothing.

2 (8) Boarding any vessel about to arrive at her  
3 destination before such arrival is complete.

4 (9) Sledding on the Capitol grounds when the  
5 Capitol Police are directed to prevent any portion of  
6 the Capitol grounds from being used as a play-  
7 ground.

8 **SEC. 3. REPEAL OF FEDERAL PROVISIONS.**

9 (a) Section 336 of title 18, United States Code, is  
10 repealed.

11 (b) Subsections (b), (c), and (d) of section 407 of the  
12 Federal Food, Drug, and Cosmetic Act (21 U.S.C. 347)  
13 are repealed.

14 (c) Chapter 309 of the Act of March 3, 1927 (7  
15 U.S.C. 491; 44 Stat. 1355) is repealed.

16 (d) Section 1720 of title 18, United States Code, is  
17 amended by striking "Whoever unlawfully and willfully re-  
18 moves from any mail matter any stamp attached thereto  
19 in payment of postage; or".

20 (e) Section 486 of title 18, United States Code, is  
21 amended by striking "or of original design."

22 (f) Section 11110 of title 46, United States Code, is  
23 amended by striking the second sentence.

24 (g) Section 2279 of title 18, United States Code, is  
25 repealed.

1 (h) The Act entitled “An Act to protect the public  
2 property, turf, and grass of the Capitol Grounds from in-  
3 jury.” (2 U.S.C. 1963) is repealed.

4 **SEC. 4. INTENT REQUIREMENT FOR OFFENSE RELATED TO**  
5 **UNIFORMS OF LETTER CARRIER.**

6 Section 1730 of title 18, United States Code, is  
7 amended—

8 (1) by inserting after “to be worn by letter car-  
9 riers” the following: “with the intent to commit an  
10 offense under this chapter”; and

11 (2) by striking the second undesignated para-  
12 graph.
