Witness: Amy Mek, Founder and CEO, RAIR Foundation USA

Distinguished Members of Congress: My name is Amy Mekelburg, Founder of RAIR Foundation USA. I come before you today out of profound love for this country, and at great personal cost. For 15 years, I have documented Islam's assault on Europe and its dangerous advance inside America.

For defending Western values, Islam and its left-wing allies marked my family for destruction. They stalked us, attacked my loved ones' careers, and sent death threats. Today I travel with armed security. A simple walk, a grocery run, opening my own front door, none of it is safe anymore. Islam has taken that from me.

The hardest part of this fight has been watching friends pay the ultimate price. On January 29, 2025, my friend Salwan Momika,¹ an Iraqi Christian who fled to Sweden to escape Islam, was slaughtered as I watched. Sweden put him on trial for "hate speech" for telling the truth about the threat that killed him. Salwan predicted his own assassination. He knew because the Sharia penalty for criticizing Islam is death.

A 1,400-year-old war is being waged inside our country. Muhammad, the man Muslims call their Prophet, was a military commander whose mission was to bring the world under Islamic rule. That mission cannot be completed until America falls. Islam is a hostile totalitarian political ideology using our freedoms to destroy us. To every non-Muslim, it offers three choices: convert, submit, or die. It does not stop until every court, school, and government on earth is under Sharia.

Islamic law, Sharia, is the doctrinal foundation of a hostile threat doctrine.²

This was formally analyzed and explained in Major Stephen Coughlin's Master of Science in Strategic Intelligence thesis, where he demonstrated that Sharia is not merely a personal religious code but a complete legal, political, and military system that obligates its adherents to wage jihad (warfare) against non-Muslims until they are subdued, converted, or reduced to second-class dhimmi status.

In short: Islam = Sharia = Islam.

There is no separation. Sharia is not an optional “interpretation” of Islam; it is Islam. The religion, the law, the state, and the military doctrine are one and the same under orthodox Islamic jurisprudence. What Coughlin’s work showed is that ignoring this doctrinal reality leaves the West strategically blind to the threat it faces.³

The Muslim Brotherhood turned this imperative into a modern conquest strategy. Two seized documents, the 1982 Project^{4, 5} and the 1991 Explanatory Memorandum,⁶ detail their two-front plan: build parallel Islamic societies that reject assimilation, while their faithful capture our institutions.⁷ The Brotherhood wrote the playbook.

Today every hostile Islamic regime and faction is executing it on our soil: Saudi Arabia, Iran, Turkey, Qatar, Pakistan, Hamas, and the Taliban. Different countries. Different sects. Marching in lockstep toward one conquest.

These networks operate more than 8,000 Islamic nonprofits across America, including nearly 650 in Texas alone.⁸ They have built a parallel, often sequestered, infrastructure: mosques, seminaries, schools, sharia banks, sharia courts, sharia clinics, charities, media, and political networks. This is a coordinated ideological ecosystem. Texas and Florida, the Brotherhood’s command centers, are the clearest example of the first strategy: massive fortresses where Muslims live cradle to grave under full Sharia.

In Texas, terror-tied imam Yasir Qadhi is fighting to build EPIC City, a 402-acre Sharia compound marketed as the “epicenter of Islam in North America.”⁹ In Katy, an \$80 million Sharia compound is rising¹⁰ under Brotherhood operative Main Al Qudah,¹¹ whose family includes leading terrorists in Jordan. Hamed Ghazali, explicitly named in the 1991 Memorandum, recruited Americans for Al-Qaeda.¹² Today he writes curriculum for Islamic schoolchildren across North America. Texas taxpayers are about to fund him through school vouchers.¹³

Across America, the Brotherhood is buying churches and converting them to mosques.¹⁴ A Lubbock school became a Brotherhood mosque in 45 days.¹⁵ In Dallas, two imams who preach hand amputation, sex with captives, and stoning adulterers are suing to seize a Christian megachurch.¹⁶ Garland, Texas, hosts the U.S. headquarters¹⁷ of a Pakistani jihadi network that trained hundreds of terrorists, including the recent killer of a West Virginia National Guard member.¹⁸ In Florida, third-generation Brotherhood leader Magda Elkadi

Saleh runs a self-contained Tampa enclave^{19, 20}. A Houston mosque led by an imam appointed by Iran's Supreme Leader received nearly \$1 million in tax dollars while children pledged allegiance to Khamenei, singing: "Khamenei is our leader, we are his soldiers".²¹ Another Hamas-supporting Texas mega-mosque hosted public school field trips^{22, 23} while its imam preached that fathers and brothers should kill adulterous daughters. His exact words: "If a girl commits adultery, the father, with the help of her brothers, will kill her, bury her somewhere."²⁴

Members of Congress, there is a little Muslim American girl right now, born in Texas under our Constitution, with every sacred right our forefathers fought and died to give her. She will never know one of them. Her own father, imam, and teachers raise her to believe she is worth less than a man, as Islam's texts command. If she is beaten, it is her fault. If she is raped, no American courthouse will hear her screams. If she is married off as a child to a pedophile, she will never know it is a crime.

She is shielded from her birthright, raised to hate her country, trained to subvert it. There are many thousands like her and growing fast.

This war's second strategy captures our institutions and culture from within. Their operatives have penetrated our State Department²⁵, education^{26, 27}, courts²⁸, city councils^{29, 30}, local governments^{31, 32, 33}, law enforcement agencies^{34, 35, 36} and school boards³⁷ to subvert the Constitution and replace it with Sharia.

For example, Muslim Brotherhood-linked Jomana Qaddour serves as Senior Syria Advisor in the U.S. State Department's Bureau of Near Eastern Affairs. Qaddour was attended the Islamic School of Greater Kansas City under Hamed Ghazali, a top Muslim Brotherhood

operative explicitly named in the 1991 Explanatory Memorandum and discussed in detail later in this statement.

Qaddour's father, Jihad Qaddour, served as Treasurer and board member of the Muslim American Society (MAS), a direct Muslim Brotherhood front, and founded Brotherhood-linked organizations in Kansas tied to Ghazali and Brotherhood national leader Ahmad Elkadi. The family's Syria Relief and Development and Syrian Emergency Taskforce groups connect to Hamas supporters, Brotherhood networks, and post-Assad Islamic forces who are now running Syria. Jomana Qaddour worked with the now-defunct MAS Freedom Foundation, including events backing Hamas. She joined a Gaza convoy with known Hamas-linked figures, sat on the board of terror-tied Islamic Relief USA, and advanced through leftist national security pipelines into the Biden administration. She now shapes U.S. policy toward the new Syrian regime dominated by former al-Qaeda affiliate HTS. These documented ties expose active Brotherhood infiltration at the highest levels of American foreign policy.

Hamas, doing business as CAIR, has trained 50,000 lawyers, journalists, filmmakers, and influencers to embed Islam and rewrite our history.³⁸ When we object, they scream "Islamophobia".³⁹ Their super PACs flood our elections;⁴⁰ mosques run voter drives.⁴¹ Beside me is fifteen-year-old Marco Hunter-Lopez. He will tell you how a Texas branch of the Muslim Students Association (MSA), the Muslim Brotherhood's student arm - which was founded by EPIC City's Yasir Qadhi's father Mazhar Kazi - is targeting Texas children.⁴² They handed out Qurans, hijabs, and Sharia brochures to American children. WhyIslam's own leaders openly declare - on camera - that they want America to become an Islamic nation.

Staying true to his Brotherhood roots, WhyIslam leader Jawad Ahmed praised the early pioneers of the MSA at a MAS / Islamic Circle of North America (ICNA) (MAS-ICNA) conference on April 27, 2026. Ahmed revealed that Anis Ahmed (no relation) taught him in the 1990s at the International Islamic University in Islamabad. Anis Ahmed came to America in the 1960s and traveled in MSA-linked circles and served as president of the Association of Muslim Social Scientists (AMSS). Founded in 1972 as a key outgrowth of the MSA, the AMSS was established to promote Islamic perspectives across academic disciplines and advance the “Islamization of Knowledge” project, which seeks to purge Western science and education of its perceived impurities and continues to be promoted heavily at the Muslim Brotherhood-founded International Institute of Islamic Thought (IIIT) in Virginia. According to Jawad Ahmed, his teacher Anis Ahmed stated that during his time in America with MSA-linked networks, his “job was activism.”⁴³

Anis Ahmed studied in America at Temple University under Ismail Raji al-Faruqi, the intellectual architect of the “Islamization of Knowledge” doctrine and founding president of AMSS. Al-Faruqi attended the infamous 1977 Lugano meeting alongside other exiled disciples of the Muslim Brotherhood founder Hassan al-Banna, the ideological godfather of global jihadism. It was from that meeting that the Brotherhood’s multi-generational blueprint to conquer the West from within, “The Project”, emerged.⁴⁴

For speaking out, Marco’s safety was threatened. Our nation’s leaders are failing children.

The Muslim Brotherhood's "The Project" - A Blueprint for the Islamization of America

The Muslim Brotherhood's long-term strategy for the gradual Islamization of the West is a documented operational plan that has been actively implemented inside the United States for decades.⁴⁵ At the center of this effort stands a 1982 document known as "The Project" (formally "Towards a Global Strategy for Islamic Policy"). This 12-point master plan outlines a patient, multi-generational "civilization jihad" aimed at infiltrating Western institutions, building parallel Islamic societies, rejecting assimilation, and ultimately establishing Islamic dominance."

"The Project" explicitly rejects coexistence with Western values. It calls for the creation of parallel Islamic structures governed by Sharia, the strategic use of "temporary cooperation" with leftist and anti-Western movements (the Red/Green Axis), and the deliberate cultivation of "rancor" toward Jews while refusing all coexistence. Palestine is designated as the "keystone" for mobilizing global jihad. The document instructs operatives to penetrate centers of power, dominate education and social services, build economic strength, and avoid premature confrontation while steadily advancing the "renaissance of the Arab world" and global Islamic order through institutional infiltration rather than open conflict.

"The Project" serves as the operational manual that has guided Brotherhood networks for over four decades. It closely parallels the 1991 Explanatory Memorandum - entered into U.S. federal court evidence - which describes the Brotherhood's "process of settlement" in North America as "a kind of grand Jihad in eliminating and destroying the Western civilization from within and 'sabotaging' its miserable house by their hands."

Command Center in Virginia: The International Institute of Islamic Thought (IIIT)

A primary American vehicle for executing this strategy is the International Institute of Islamic Thought (IIIT) in Herndon, Virginia. Founded directly from the 1977 Lugano planning meeting involving top Brotherhood figures, IIIT was created to advance the "Islamization of Knowledge" - a doctrine that seeks to purge Western thought from all fields of education and replace it with an Islamic worldview.

IIIT maintains deep, unbroken ties to the Brotherhood's founding ideologues and continues to operate openly with 501(c)(3) tax-exempt status. It has hosted events honoring its Brotherhood founders, featured speakers aligned with Hamas support and "settler-colonialism" narratives against Israel, and advanced curricula designed to resolve the

supposed "duality crisis" faced by Muslim students exposed to Western education. Key figures linked to IIIT helped establish major U.S. Islamic organizations, including ISNA and MSA, often with overseas funding streams.

The Brotherhood's approach is methodical and phased, as articulated by founder Hassan al-Banna: reform the individual, the family, society, government, and ultimately establish a global caliphate under Sharia. Public-facing charities, schools, mosques, and interfaith initiatives serve as the "dawah" (proselytize) front, while the strategic vision remains unchanged.

A Clear and Present Threat to American Sovereignty

This is about a supremacist political ideology that uses "religious" cover to undermine the U.S. Constitution and replace it with Sharia. The plan has advanced through captured institutions: universities, city councils, refugee resettlement networks, financial systems (Sharia-compliant finance), and influence operations that label criticism as "Islamophobia."

The Muslim Brotherhood created the ideological backbone for Hamas, Al Qaeda, and the Islamic State. Its networks in America have operated with relative impunity, often enjoying political access and taxpayer benefits while advancing a doctrine that explicitly rejects Western civilization.

America faces a choice. We can continue to allow these documented networks to operate freely from command centers like IIIT in Virginia, or we can confront the threat with the seriousness it demands. Complacency is no longer an option.

Recommendations

Congress must immediately:

- Launch a full investigation into the IIIT, its funding, leadership, affiliates, and tax-exempt status.
- Examine all Muslim Brotherhood-linked entities operating in the United States and their influence on education, finance, government, and national security.
- Review "civilizational jihad" strategies and the compatibility of political Islam/Sharia supremacism with the U.S. Constitution.
- Hold public hearings to educate the American people on these documented threats.

The Muslim Brotherhood did not conceal its intentions. They wrote them down. The question before Congress is whether the United States still possesses the will to defend its sovereignty against a patient, determined ideological adversary operating within our borders. The time for decisive action is now.

RAIR Foundation USA Research: Patterns of Sharia-Adherent Expansion, Institutional Networks, and Parallel Society Development in Texas (and Select National Linkages)

RAIR Foundation USA's investigative research documents a coordinated, multi-layered expansion of Islamic institutions across Texas. This includes large-scale residential and commercial enclaves, conversions of former Christian churches into mosques and schools, full-time Islamic academies and seminaries, university-linked facilities, Sharia councils, halal economic initiatives, and political engagement. These efforts repeatedly emphasize strict Sharia compliance, waqf (inalienable and permanent Islamic endowment) structures⁴⁶, foreign-trained leaders, taxpayer-supported programs, and explicit goals of non-assimilation, demographic consolidation, and Hijrah (Islamic migration) settlement. The research draws from documented statements by leaders, fundraising materials, constitutional bylaws, fatwas, and public events.

The flagship example is EPIC/The Meadows (East Plano Islamic Center), Plano, Texas, a proposed 400-acre Sharia-adherent residential and commercial compound near Dallas.⁴⁷ It features 74 homes sold only to Muslims affiliated with EPIC, a massive mega-mosque anchoring the enclave, Sharia-adherent Islamic schools enforcing religious doctrine, and UIF Corporation offering only Sharia-compliant financial services. A fortress-like home was built beside the Plano Police Academy, overlooking SWAT vehicles, bomb trucks, and tactical zones. Leader Yasir Qadhi is an open member of the International Union of Muslim Scholars (IUMS), a Qatar-based Muslim Brotherhood group founded in 2004 by the late Brotherhood "spiritual leader" Yusuf al-Qaradawi.⁴⁸ The IUMS is deeply tied to the United States designated terrorist group Hamas.⁴⁹ Qadhi has trained youth operatives in Turkey alongside a U.S.-banned senior Muslim Brotherhood leader, Tareq Al-Suwaidan⁵⁰ (which also included Imam Omar Suleiman from Valley Ranch Islamic Center).

Additional major Sharia enclaves and church conversions include the following: In Georgetown, the Georgetown Islamic Center⁵¹ is building a self-contained Sharia enclave on over 8 acres (6.2-acre campus plus an extra 2-acre land grab secured at half value through neighbor cultivation). It operates a cradle-to-imam pipeline with a full-time Quran Hifz school (ages 7+) and after-school programs indoctrinating children from age 6 in sharia (fiqh, aqeedah, hadith, tajweed) to produce “flag-bearers of Islam.” Faculty are nearly all trained in Pakistan, Afghanistan, and Bangladesh madrasas. The center maintains self-sustaining revenue (RV/truck business already generating income, with 2025 plans for halal stores, restaurants, and Islamic shops) and hosted UK Sharia jurist Mufti Mohammed Tosir Miah for lectures on building Sharia councils and Islamic seminaries. It openly states the goal of solving the U.S. imam shortage (over 3,000 mosques) by training and deploying leaders nationwide via a new seminary, following classical dawah sequences (invite to jizya to war per Reliance of the Traveler) and framing donations as Sadaqah Jariyah for the global Ummah.

In Katy, former farmland is being converted into a 30-acre, \$80 million Sharia enclave called Al Huda Islamic Center. It will feature a large mosque, K-12 school, an Islamic university (Guidance College), apartments, a strip mall, and more. Leader Main Al Qudah is tied to bin Laden and Al-Qaeda networks through his work at the Islamic Society of Arlington in Texas. His father and uncle were Muslim Brotherhood members. He sits on the Assembly of Muslim Jurists of America’s Resident Fatwa Council, where he issues Sharia rulings such as death for apostasy and blasphemy, support for symbolic wife-beating, hatred for non-Muslims’ disbelief, and using zakat funding for “legitimate Jihad activities.”

In Sachse, the Sachse Muslim Society (SMS) / Dallas Muslim Community Center (DMCC)⁵² converted a 56,000 sq ft former Christian mega-church (plus 4 acres, gym, classrooms, and 300 parking spaces) into one of the largest Islamic centers in Texas, with leaders stating: “We can just go in tomorrow.” A separate Dallas Muslim Community Center effort is taking over a former 40,000 sq ft Baptist church to create a dawah academy and seminary. Both feature Sharia financing (qard-e-hasan loans), permanent waqf status, and the relocation of Salafi imams Sheikh Karim Abu Zaid and Sheikh Uthman Ibn Farooq. Abu Zaid openly promotes Sharia, advocates punishments such as flogging and stoning adulterers, called COVID-19

divine punishment for homosexuality and adultery, expressed support for the Taliban's policies toward women, and expressed support for Hitler's philosophy on exterminating Jews. Uthman Ibn Farooq supports harsh hudud punishments such as chopping off the hands of thieves, runs aggressive anti-Christian dawah videos to debunk the Trinity, mock the Resurrection, and deny Jesus' divinity, is banned from the UK and Canada, and supports sexual relations with female slaves. Leaders frame the church-to-mosque takeovers as symbolic Islamic dominance mirroring 1,400-year patterns (such as Hagia Sophia in 1453) and part of a broader Hijrah invasion targeting Texas, which has resettled over 57,000 refugees.

In Rowlett, the Islamic Center of Rowlett⁵³ converted a church to a mosque and had Siraj Wahhaj (unindicted co-conspirator in the 1993 World Trade Center bombing, whose son was convicted for operating a terrorist training compound involving children) help with fundraising. In the Ft. Worth area, the Islamic Center of Haltom City⁵⁴ converted the Christ Way Bible Church into a mosque. In DeSoto, the DeSoto House of Peace is the largest mosque in Texas, with the largest mosque parking lot in America: a \$17 million, 51,000 sq ft mega-mosque that holds 3,500 worshippers, with an Islamic school, 10,000 sq ft gym, and Islamic store and cafe inside the mosque.

In McKinney, the McKinney Islamic Association is building a 40,000 sq ft hub. The imam, Mohamed AlGebaly, was sent by the Egyptian government to Texas and is President of the Islamic Tribunal, a Sharia-type court operating in Texas. In Tyler, the imam at the East Texas Islamic Society / Tyler Mosque⁵⁵ is Hisham Bakr Khalaf, a graduate of Al-Azhar University officially certified by Egypt's Ministry of Awqaf to bring state-approved Sharia agendas to America, such as death for apostates and homosexuals. In Plano, Masjid Salahadeen⁵⁶ features Imam Yusha Evans, who says apostasy is punishable by death, any Muslim who rejects Sharia has "exited the religion entirely," and promotes polygamy.

In Houston, the Medical Center Islamic Society⁵⁷ (MCIS) is led by Dr. Salah al-Sawy, the Secretary General of the Assembly of Muslim Jurists of America (AMJA), a Sharia council. AMJA has issued fatwas endorsing the death penalty for apostates, permitting female circumcision as “honorable,” stating that forced sex in marriage is not rape under Islamic law, rejecting the legitimacy of U.S. law and Constitution, urging Muslims to prioritize Sharia and avoid full integration or loyalty to non-Muslim governments, and discussing conditions for jihad (defensive now, but potentially offensive if a Caliphate is declared). The Houston Quran Academy, now poised to receive Texas taxpayer funding through the school choice program, is run by Hamed Ghazali, explicitly named in the 1991 Explanatory Memorandum. He was on the Muslim Brotherhood’s Board of Directors in the 1990s, a close companion to Muslim Brotherhood spiritual leader Yusuf al-Qaradawi, ran Ghazali Islamic Video producing jihad recruitment videos pre-9/11, solicited funds and weapons for Afghan mujahideen and the Occupied Land Fund (later the Holy Land Foundation, convicted of funneling over \$12 million to Hamas), promoted Sayyid Qutb’s Milestones (the ideological blueprint for al-Qaeda and Hamas), and endorsed the fatwa calling for Salman Rushdie’s death.

Further Texas Islamic centers and mosques documented by RAIR include the Islamic Center of Quad Cities (ICQC)⁵⁸ in Frisco (5.7 acres, 24,000 sq ft mega-mosque with a strict unamendable Sharia constitution forbidding modernist views, routing disputes to the North Texas Islamic Council, and led by Mufti Imam Tawsif Quabili), the Islamic Center of Pflugerville⁵⁹ (8,000 sq ft expansion with full-time Islamic school, cricket pitch, and soccer field; imam Mufti Umer Farooq Saleem trained 12 years at Jamia Ashrafia in Lahore), the Unity Center in Lubbock⁶⁰ (former Arnett Elementary School converted to mosque in 45 days, led by Mohamad Altabaa with ties to CAIR operative Hassan Shibly and Yasir Qadhi), the Pearland Islamic Center (PIC) / Shadow Creek Muslim Community Center (SMCC) in

Pearland⁶¹ (30,000 sq ft master plan and 3.3 acres tied to Islamic Society of Greater Houston, with MSA links and prison dawah / Afghan resettlement), Renaissance Academy⁶² (NAIT) in North Austin (19-acre waqf campus with masjid, K-12, auditorium, and athletics; late imam Islam Mossaad called for Muslim-Marxist alliances against “Zion American Imperialism” and support for CAIR), the Nueces Mosque at the University of Texas at Austin⁶³ (74,677 sq ft vertical complex with 600 prayer spaces, seminary, and 32 apartments; Saudi funding and MSA ties, slogan “What Starts Here, Changes the Ummah”), the Three In One Mega Church Conversion⁶⁴ (Salahuddin Future Academy / Masjid Dar Al-Tawhid / AIM Dawah Academy and Seminary, 40,000 sq ft former church turned into mosque, K-12 academy, and dawah seminary with “Islamization of Knowledge” curriculum rejecting basic science and training students to refute Western values), The Islamic Center of Aubrey⁶⁵ (purchased 25 acres of land to launch a multi-phase Islamic expansion project), the Islamic Center of Brushy Creek⁶⁶ (used as polling station), the Islamic Center of Frisco,⁶⁷ San Antonio’s Islamic Center,⁶⁸ Plano Masjid⁶⁹ (imam’s wife-beating allegations), the North Austin Muslim

Community Center⁷⁰ (NAMCC), the Mesquite Islamic Center⁷¹ (MIC), the Madrasah Islamiah and Darul Quran project⁷² (boarding school), the Islamic Association of North Texas⁷³ (IANT) in Richardson, the Islamic Center of San Antonio⁷⁴ (converting families and teens), Al-Hadi School in Houston⁷⁵ (Shia influence), MAS Katy⁷⁶ (tied to shooting), and others.

Educational and youth pipeline efforts documented by RAIR include MSA takeovers or influence⁷⁷ at Wylie East High School,⁷⁸ Round Rock High and Cedar Ridge High⁷⁹ (Qurans stocked while Bibles removed online), field trips from Kingwood and Atascocita High Schools to the IslamInSpanish Centro Islamico,⁸⁰ Ramadan in schools,⁸¹ Mesquite Public

Plaza Grand Opening in Richardson,⁹² Islamic bills in Texas,⁹³ Key to Houston,⁹⁴ DeSoto Ramadan Proclamation,⁹⁵ McKinney Ramadan Proclamation, Muslim Heritage Month in Austin,⁹⁶ Pakistanification of Texas,⁹⁷ and Sugarland City Hall prayer. Texas taxpayers have sued to fund Muslim Brotherhood operative's Islamic schools (Houston Quran Academy Spring) and bankrolled an Iranian Regime propaganda center (Islamic Education Center of Houston).⁹⁸

child bride fatwas, and a Taliban-loving imam¹⁰⁴ (Bo French documentation), a daughter killed for not wearing hijab,¹⁰⁵ MAS Katy tied shooting, Sharia patrols,¹⁰⁶ and Prophet Mohammad parades. Additional notes reference Sharia courts (Bo French), Marxism to Islam, and converting families and teens.

Halal and economic parallel systems extend to Buffalo Wild Wings¹⁰⁷ in Dallas and Texas public schools. The All-Muslim Commerce App GoMarhaba functions as a boycott-and-redirect tool (signed by CAIR-Florida Deputy Executive Director Hiba Rahim) directing users exclusively to Muslim-owned businesses. Dallas Police Chief is criticized for handing U.S. security to Qatar¹⁰⁸ (Hamas's banker). Mosque polling sites are documented.

A powerful example of the Red/Green Axis in Texas is Texas Rep. Julie Johnson,¹⁰⁹ a lesbian Democrat, poses as a fighter against extremism while actively advancing a Red-Green Alliance that merges radical leftist and Islamist forces in Texas. She allies with communist-linked organizers like those in the Texas Organizing Project and Soros-funded networks, while embracing Islamic militants including Imam Yasir Qadhi and his EPIC City project. Johnson champions unrestricted abortion, extreme queer and trans activism, open borders, and foreign Islamic grievances such as support for Imran Khan and Pakistan's PTI, all while attacking common-sense Texas laws protecting children from sexual performances, gender medical interventions, and unfair sports competition.

Her endorsements from groups tied to accused pedophile Terry Bean, co-founder of the Human Rights Campaign and LGBTQ+ Victory Fund, and her partnerships with figures who call for executing homosexuals expose the alliance's raw pursuit of power over principle or

consistency. Johnson prioritizes building a coalition that undermines Western values through tactical unity between Marxists and Islamists, importing Sharia-aligned agendas into Texas politics under the cover of "human rights" and anti-Islamophobia rhetoric. This is the Red/Green Axis in practice.¹¹⁰

National and Florida linkages appear through figures such as Magda Elkadi Saleh^{111, 112} (daughter of U.S. Muslim Brotherhood national leader Ahmed Elkadi in the 1980s; granddaughter of early Brotherhood leaders in Egypt including economist Mahmoud Abu-Saud who helped founder Hassan al-Banna expand the movement). She serves as president of Tampa's first Muslim-led resettlement agency Radiant Hands, partner of Islamic Relief USA, works closely with CAIR-Florida, was Vice President of the Islamic Society of North America (ISNA), principal at Bayaan Academy, co-founder of Universal Academy of Florida, former head of the renamed terror-tied Islamic Academy of Florida (originally founded by Sami Al Arian and Palestinian Islamic Jihad leader Ramadan Shalah), and leads the Council of Islamic Schools of North America (CISNA) and Islamic Society of Latin America (ISLA). She stresses orienting American society toward Islamic law and values while building the 14-acre Bayaan Powerhouse community center in Pasco, Florida. The Islamic Tampa Area Muslim Professional Association (iTAMPA)¹¹³ explicitly prioritizes Muslim-only healthcare networks, Sharia-compliant Amir and shura governance over medicine, education, law, dawah, and commerce, and seeks to replicate the EPIC-style enclave model with parallel systems insulated from outside oversight.¹¹⁴

Muslim Brotherhood Leaders in America

The following represents some of the main Muslim Brotherhood operatives working today in Florida and Texas:

HAMED GHAZALI

Summary

Hamed Ghazali¹¹⁵ is a longtime Muslim Brotherhood operative based in Houston, Texas, who has directed Islamic schools and curricula across the United States for over three decades. Explicitly named in the Brotherhood's 1991 Explanatory Memorandum as a central architect of its plan to "destroy Western civilization from within," Ghazali ran Ghazali Islamic Video (GIV), the primary pre-9/11 jihadi recruitment platform in America. He personally interviewed top al-Qaeda recruiters including Tamim al-Adnani (second-in-command to Osama bin Laden's mentor Abdullah Azzam) and Abdullah Azzam himself, soliciting funds, weapons, and American Muslim fighters for the Afghan jihad and for the Holy Land Foundation, which was convicted of funneling over \$12 million to Hamas. Today Ghazali leads the Houston Quran Academy and co-leads Guidance College, both of which actively seek Texas taxpayer voucher funds to expand Sharia-based education.

History

- Named in the 1991 Muslim Brotherhood Explanatory Memorandum as a central architect of the plan to "destroy Western civilization from within and sabotage its miserable house."
- Sat on the Muslim Brotherhood "Board of Directors" in 1992 with Ahmed Elkadi.
- Produced and distributed videos through Ghazali Islamic Video (GIV), the primary pre-9/11 jihadi recruitment platform in the United States.
- Personally interviewed Tamim al-Adnani (second-in-command to Abdullah Azzam, Osama bin Laden's mentor and al-Qaeda co-founder) multiple times, during which al-Adnani solicited weapons support and recruits from American Muslims.
- Distributed recruitment footage of Abdullah Azzam at the 1988 Muslim Arab Youth Association (MAYA) convention and was listed as a MAYA organizer (MAYA co-founded by Osama bin Laden's nephew Abdullah A. bin Laden).

- Solicited funds for the Occupied Land Fund (later convicted as Holy Land Foundation/HLF, which sent over \$12 million to Hamas).

- Spent four days in 1990 as a special companion of Muslim Brotherhood spiritual leader Yusuf al-Qaradawi.

- Director of Houston Quran Academy (formerly Al Noor Islamic Academy, launched under MAS Houston; expanded by Ghazali in 2009; now on MAS Katy campus; plans to raise tuition to match Texas voucher amount).
- Co-leader with Main Al Qudah of Guidance College (formerly Al-Huda University, founded 2012 under MAS Katy).
- Founder of Alhuda University.
- Former Superintendent of Iman Academy of Houston.
- Frequent speaker at MASCON TX conventions, ICNA-MAS conventions, and Islamic Dawah Center in Houston.

Associated Terrorist Organizations

- Muslim Brotherhood (explicitly named in its 1991 Explanatory Memorandum).
- Al-Qaeda (via recruitment of mujahideen through GIV interviews with al-Adnani and Azzam).
- Hamas (via direct solicitation for Holy Land Foundation/Occupied Land Fund).
- Muslim Arab Youth Association (MAYA, co-founded by bin Laden’s nephew).

MAGDA ELKADI SALEH

Magda Elkadi Saleh^{116, 117} is a second-generation Muslim Brotherhood leader operating in Tampa, Florida, where she serves as principal of Bayaan Academy and previously led the American Youth Academy and co-founded the Universal Academy of Florida. She is the daughter of Ahmed Elkadi, the national leader (General Mas'ul) of the U.S. Muslim Brotherhood from 1984 to 1994, and granddaughter of Mahmoud Abu-Saud, an early Egyptian Brotherhood official who helped founder Hassan al-Banna expand the organization and co-authored "The Project," the Brotherhood's 1982 strategy for conquering the West. Saleh's schools were founded by convicted Palestinian Islamic Jihad (PIJ) operatives Sami al-Arian and Ramadan Shalah; she now receives millions in Florida school-choice vouchers while serving as Vice President of the Muslim Brotherhood-linked Islamic Society of North America (ISNA) and partnering with CAIR-Florida to resettle migrants and build parallel Islamic institutions.

History

- Daughter of Ahmed Elkadi (U.S. Muslim Brotherhood General Mas'ul/national leader 1984–1994; president of North American Islamic Trust/NAIT; key architect of ISNA, MAS, and other Brotherhood institutions).
- Granddaughter of Mahmoud Abu-Saud (early Muslim Brotherhood leader in Egypt who helped founder Hassan al-Banna expand the organization; co-founder of American Muslim Council with convicted terrorist financier Abdurahman Alamoudi; attended 1977 Lugano meeting that produced "The Project" strategic document).
- Both maternal and paternal grandfathers were early Muslim Brotherhood leaders in Egypt.
- Co-founded Universal Academy of Florida (UAF) in 1992.
- Served as principal of American Youth Academy (AYA, formerly Islamic Academy of Florida founded by Sami Al Arian and Ramadan Shalah, both convicted/providing material support to Palestinian Islamic Jihad/PIJ).

MAIN AL QUDAH

His father and uncle were Muslim Brotherhood members; he openly advocated replacing secular law with Sharia in Jordan before entering the U.S. in 2000 to replace the imam of the Islamic Society of Arlington, a mosque tied directly to Osama bin Laden's network. Al Qudah earned his PhD from American Open University, whose president co-founded an al-Qaeda financing front with bin Laden's nephew and ran the U.S. branch of World Assembly of Muslim Youth (WAMY), which was raided for terrorism financing. He sits on the Assembly of Muslim Jurists of America's fatwa committee, issuing rulings supporting wife-beating, hatred of non-Muslims, death for apostates, and jihad funding, while co-leading taxpayer-funded schools with Hamed Ghazali.

History

- Father and uncle were members of the Muslim Brotherhood.
- Admitted in U.S. Court of Appeals testimony that he advocated imposition of Islamic law (Sharia) over secular law in Jordan and faced interrogation for his Muslim Brotherhood family ties.

Addendum 1: Response to Joint Statement Submitted by Representatives André Carson, Ilhan Omar, Rashida Tlaib, and Delia Ramirez

I respectfully submit this Addendum to provide additional context and clarification for the official record of the House Judiciary Subcommittee on the Constitution hearing titled “Sharia-Free America: Why Political Islam & Sharia Law Are Incompatible with the U.S. Constitution, Part II,” held May 13, 2026.

In their joint written testimony,¹¹⁹ Representatives André Carson, Ilhan Omar, Rashida Tlaib, and Delia Ramirez assert that the hearing “directly contributes to the dangerous dehumanization of American Muslims,” promotes “stereotypes and prejudice,” “demonizes a population solely based on their faith” in violation of the First Amendment, and ignores the contributions of American Muslims.

I respectfully disagree. The hearing examined whether political Islam and Sharia as a system of governance are compatible with the U.S. Constitution - a core issue of congressional oversight. Legitimate constitutional scrutiny of any ideology is not dehumanization, nor does it constitute “violence” or “discrimination” against individuals.

Conflating criticism of a political-legal doctrine with hostility toward people of a particular faith is a rhetorical tactic that chills debate.

Constitutional Clarity

Article VI of the U.S. Constitution¹²⁰ declares this Constitution, and the Laws of the United States made in pursuance thereof, to be “the supreme Law of the Land.” The First Amendment protects the free exercise of personal religious belief and the right of the people to criticize political and ideological systems. It does not shield any political doctrine -including one that claims supremacy over the Constitution itself - from examination.

Historical Context

The Founders directly confronted political Islam rooted in Sharia doctrine during the Barbary pirate conflicts. In 1786, Thomas Jefferson and John Adams were told by the ambassador from Tripoli that attacks on American ships, enslavement of crews, and demands for tribute were justified by the Quran, because nations that do not acknowledge Muslim authority are sinners and it is the right and duty of Muslims to make war upon them.¹²¹

Jefferson studied the Quran and, as President, authorized the First Barbary War (1801–1805). The United States rejected the premise that Sharia-based claims could override American sovereignty.¹²²

George Washington called religion and morality “indispensable supports” for political prosperity. John Adams declared, “Our Constitution was made only for a moral and religious people. It is wholly inadequate to the government of any other.” The Founders built one republic under one supreme Constitution, not a patchwork of competing legal systems.¹²³

Addressing Contributions and Individual Rights

American Muslims, like all citizens, deserve the full protection of the Constitution. However, highlighting this protection does not resolve the substantive constitutional questions raised by classical Sharia’s treatment of apostates, women, non-Muslims, and its claim of ultimate authority. Peaceful personal faith is protected; political systems that demand parallel or superior legal authority are properly subject to debate.

The “Sharia-Free America” hearings defend the principle that America has one Constitution, which must remain supreme under Article VI. They are not an attack on any faith community.

I respectfully submit this Addendum to provide additional context and clarification for the official record of the House Judiciary Subcommittee on the Constitution hearing titled “Sharia-Free America: Why Political Islam & Sharia Law Are Incompatible with the U.S. Constitution, Part II,” held May 13, 2026.

On March 3, 2026, a coalition of organizations including American Atheists, the Council on American Islamic Relations (CAIR), the American Civil Liberties Union (ACLU), and others sent a letter to Chairman Roy and Ranking Member Scanlon opposing the Subcommittee’s hearings.¹²⁴ The letter characterizes the hearing as “religiously discriminatory,” an “attack on religious freedom,” and an effort to “sow fear and conspiracy theories about an entire religion.” It further claims that such scrutiny leads to violence and stigmatization against Muslims.

I respectfully disagree. The hearing was a legitimate exercise of congressional oversight examining whether political Islam and Sharia as a system of governance are compatible with the U.S. Constitution. Constitutional scrutiny of a political-legal doctrine is not an attack on religious freedom, nor is it discrimination against individuals.

Addressing Claims of Discrimination and Violence

The coalition letter asserts that “as a result of repeated waves of anti-Muslim rhetoric, Muslims across the country have suffered violence, intimidation, and stigmatization.” Much of this assertion relies on reports from organizations such as the CAIR, which claimed a record 8,683 complaints of “Islamophobia” in 2025. However, these figures consist entirely of self-reported allegations submitted directly to CAIR, with no requirement for police reports, court records, medical documentation, or independent verification.¹²⁵

Such unverified statistics risk conflating legitimate law enforcement actions, immigration enforcement, and public scrutiny of political Islam or terrorism-related incidents with unlawful discrimination or violence. For example, spikes in complaints were reported following events such as the exposure of Somali fraud schemes in Minnesota and the shooting of two National Guardsmen by an Afghan Muslim immigrant. Americans have the right to condemn crime, terrorism, and foreign influence without being labeled as engaging in “anti-Muslim rhetoric.” Unsubstantiated claims of systemic “Islamophobia” should not be used to shield political ideologies or subversive activities from constitutional examination.

Constitutional Clarity and Historical Context

Article VI of the United States Constitution declares this Constitution, and the Laws of the United States made in pursuance thereof, to be “the supreme Law of the Land.”¹²⁶ The First Amendment to the United States Constitution protects the free exercise of personal religious belief and the right of the people to criticize political and ideological systems. It does not shield any political doctrine - including one that claims supremacy over the Constitution itself - from examination.

The coalition letter quotes Thomas Jefferson’s Virginia Statute for Religious Freedom (1786) and his reference to “the Mahometan.” However, in that same year Jefferson and John Adams met with the ambassador from Tripoli and were explicitly told that Barbary pirates attacked American ships, seized cargo, and enslaved crews because it was written in the Quran that nations not acknowledging Muslim authority are sinners, and it is the right and duty of Muslims to make war upon them and enslave captives.¹²⁷

Thomas Jefferson responded by launching the First Barbary War (1801–1805) to defeat this theocratic piracy. Jefferson supported broad religious tolerance for individuals (“the Mahometan”) while rejecting Sharia-based political aggression.

Addressing Claims of Discrimination and Violence

Sharia - understood as a comprehensive political and legal system claiming divine authority over every aspect of life, with built-in inequalities for non-Muslims, women, and apostates - raises legitimate constitutional questions under Article VI. Labeling constitutional debate as “fearmongering” or “bigotry” is a tactic designed to place a political ideology beyond criticism. The “Sharia-Free America” hearings do not attack any faith community. They defend the principle that America has one Constitution, which must remain supreme under Article VI.¹²⁸

Addendum 3: Response to Representative Pramila Jayapal’s Claims Regarding the Islamic Society of Orange County (ISOC)

In her remarks during the hearing, Representative Pramila Jayapal stated:

“...you have to look no further than the Islamic Society of Orange County, which last month experienced a spike in threats after Ms. Mek...uh published some tweets without foundation that they were trying to start a Sharia compound there. It was complete fiction, but it caused a spike in threats.”

This characterization is incorrect. The Islamic Society of Orange County’s own 1994 Restated By-Laws, unanimously approved by its membership on November 6, 1994, state in Section 3.2 (Conformity to Islam):¹²⁹

“All acts (explicit or implied) of the Society shall be in conformity with the Shariah, the basic sources of which are the Holy Quran and the Sunnah.”

These bylaws, which were published in full at RAIR Foundation USA,¹³⁰ further establish Sharia as the governing framework for the organization’s governance, finances, education, dispute resolution, and all operations. Reporting on an organization’s own publicly available, member-approved governing documents is protected speech grounded in primary sources, not “complete fiction.”

While the Los Angeles Times article dated April 17, 2026¹³¹ (later entered into the record by Ranking Member Mary Gay Scanlon via unanimous consent) references online comments and notes that Garden Grove Police stepped up patrols, it provides no public record of specific criminal police reports filed or any charges resulting from those comments. Legitimate concerns about a major expansion project and an organization’s explicit commitment to Sharia in its bylaws do not equate to incitement. Protected First Amendment speech should not be conflated with violence.

The Los Angeles Times article dated April 17, 2026, rather than addressing the substantive concerns raised by RAIR Foundation USA’s reporting - specifically ISOC’s own governing documents requiring full conformity with Sharia - instead opted to characterize RAIR as an “anti-Muslim hate organization and website.” It further quoted CAIR-LA’s legal director, Amir Shabaik, who stated: “It’s a hate group through-and-through... There’s obviously a clear, hateful agenda being pushed here.”

This approach is unfair and unhelpful. It offers no substantive rebuttal to the primary-source evidence contained in ISOC’s 1994 Restated By-Laws. Relying on anonymous social media comments to establish a “spike in threats,” while largely bypassing the organization’s own explicit bylaws, does not constitute meaningful engagement with the issues. Criticism of an organization’s documented positions should not be reflexively dismissed as hate or misinformation. Attacking the messenger for citing publicly available internal documents is an unfortunate tactic that undermines legitimate constitutional oversight and public discourse.

The LA Times article does not substantively address ISOC’s bylaws or expansion plans. Instead, it relies on CAIR-LA’s characterization of RAIR Foundation USA and anonymous social media comments. This approach fails to rebut the documented facts presented in ISOC’s own governing documents and does not provide a factual basis for dismissing the reporting as “without foundation.”

Thank you for the opportunity to respond to the submission of “Christian Nationalism and Violence Against Religious Minorities in the United States” by Nilay Saiya and Stuti Manchanda (Journal for the Scientific Study of Religion, 2025).¹³²

This submission entered into the congressional record should be rejected outright. This paper is a transparently partisan document that fails at every level of serious empirical inquiry. It deserves no weight in policy debates.

Right at the outset, the authors declare that the Christian nationalism is “linked” to “racist, misogynist, authoritarian, homophobic, antivaccine, antiscience, and violent views.” The Singapore-based authors claim that Christian nationalism is “seeks to amalgamate the Christian faith and a country’s political life and calls for the privileging of a certain form of Christianity in the public square”.

Their sole evidence is a long string of citations, nearly all pointing to the same narrow group of researchers: Andrew Whitehead, Samuel Perry, Joseph Baker, and their frequent collaborators. This fails the most basic attempt at a literature review, serving more as an echo chamber.

The authors further bolster their claims by citing polling from the Public Religion Research Institute (PRRI),¹³³ asserting that “white Americans who agree with the statement that ‘God intended America to be a promised land for European Christians’ are more than four times as likely as those who disagree with that statement to believe that ‘true American patriots may have to resort to violence in order to save our country’”. This relies on a survey item that inserts a racially-loaded “European Christians” qualifier rarely present in ordinary American discourse about the nation’s Christian heritage. Notably, the very same flawed and biased PRRI report was also submitted into the congressional record.

Whitehead, Perry and Baker dominate the quantitative “Christian nationalism” literature. Their flagship work - including the 2020 book *Taking America Back for God*¹³⁴ and dozens of articles - relies on a 6-item survey scale that measures agreement with statements such as “The federal government should declare the United States a Christian nation,” support for prayer in schools, or the idea that America’s success is part of God’s plan.

As Smith & Adler (2022) demonstrate¹³⁵ in their rigorous methodological critique (“What Isn’t Christian Nationalism? A Call for Conceptual and Empirical Splitting”), this scale and the broader research program suffer from serious conceptual and measurement problems.

It fails to cleanly distinguish Christian nationalism from generic support for religion in public life or American civil religion.

This flawed foundation undermines the entire paper. The empirical analysis built upon it - subjective hand-coding of senators’ statements and near-zero counts of alleged “Christian attacks” from the Global Terrorism Database - collapses under even modest scrutiny.

In short, this is not credible social science. It is motivated advocacy dressed in regression tables. Congress should dismiss it as the partisan document it clearly is.

Addendum 5: Rebuttal to the Center for American Progress Report “How White Supremacy Returned to Mainstream Politics”

I respectfully submit this Addendum to address the Center for American Progress (CAP) report titled “How White Supremacy Returned to Mainstream Politics”¹³⁶ by Simon Clark (July 1, 2020), which was entered into the hearing record.

The Center for American Progress (CAP) was founded in 2003 by John D. Podesta, a long-time fixture in democratic politics. Described as “an aggressive part of the left-wing political machine”, George Soros was one of CAP’s major early funders.¹³⁷

This report is a partisan policy brief that broadly equates mainstream conservative positions with “white supremacy.” For example, the report singles out Stephen Miller, a senior Trump administration official, and accuses him of advocating “the most extreme white supremacist concepts,” including the “great replacement” theory, and fears of “white genocide through immigration”. It labels standard immigration enforcement, border security measures, and concerns about cultural assimilation as white supremacist ideas.

The report employs expansive definitions, guilt-by-association tactics linking mainstream figures to fringe extremists, and selective sourcing to stigmatize legitimate political debate on national sovereignty as extremism. It does not offer rigorous empirical analysis or falsifiable claims; it advances a political narrative designed to delegitimize opponents.

The Center for American Progress has a documented track record of producing reports designed to advance progressive political goals. This particular document inflates the threat of “white supremacy” to tar ordinary conservative viewpoints as racist, a tactic repeatedly used to shut down debate on issues such as illegal immigration, cultural assimilation, and constitutional sovereignty.

The hearing properly examined whether political Islam and Sharia as systems of governance are compatible with the U.S. Constitution. America benefits from open debate on ideas, not from reports that smear millions of citizens as extremists for holding mainstream views on national sovereignty and the rule of law.

Addendum 6: Rebuttal to “Active Clubs are white supremacy’s new dangerous frontier”

I respectfully submit this Addendum to address the article titled “Active Clubs are white supremacy’s new dangerous frontier” published by The Conversation in August 2025,¹³⁸ which was entered into the hearing record.

This article is an opinion piece that broadly labels decentralized fitness and self-improvement groups as a “white supremacist” threat. It relies heavily on advocacy organizations such as the Anti-Defamation League (ADL) and the Southern Poverty Law Center (SPLC) for its claims while offering little rigorous evidence of widespread criminal activity.

Most importantly, this article is completely irrelevant to the subject of the hearing. The subcommittee was examining whether political Islam and Sharia as systems of governance are compatible with the U.S. Constitution.

Introducing a piece about fitness-oriented groups has no substantive connection to that constitutional question. It appears to be an attempt to deflect attention from the actual topic under discussion.

Equating this legitimate constitutional oversight with the broad-brush claims in the article is a false equivalence. One addresses documented ideological and legal conflicts with the supreme law of the land. The other advances a narrative designed to pathologize mainstream cultural and political concerns.
