Hearing Testimony on April 19<sup>th</sup> 2016. Subcommittee on Immigration and Border Security

My name is Laura Wilkerson, my family became a victim of Illegal Alien Crime on November 16, 2010. This was our families attack by a foreign invader, whom is in this country illegally. At best guess his family are still enjoying the fruits of America at the hands of taxpayers. I do not know this as a fact, because the United States Government does not know either.

My Youngest Son, Joshua was a senior in high school and had his whole life ahead of him. He went to school and never returned. As Josh walked up to the doors of the school that morning. Hermilo Morales walked up as well. This is the last picture of my child alive. This killer asked Josh for a ride home from school and Josh said yes. Josh held the door open to allow him in and he shook his head no, he wasn't coming in to school. Josh allows the door to close and walks out of the frame headed to class.

At trial, the killer testified on his behalf and gave exact testimony on how he systematically killed Josh. First a punch in the face, so his vision was off. Next a knee to Josh's abdomen so that he would go to the ground. Josh went to the ground as his spleen was sliced in half. This killer was aggravated that it was not over, he grew tired of watching bloody bubbles coming from Josh's nose as he was trying to breathe. Next he took a closet rod and beat Josh over the head again and again until the rod broke in 4 pieces. Joshua still breathing. Next he strangled him, let him go to see if it was over, nope, so he continued until there were no more bubbles. He waited and watched him die. He tied Josh's body up, stuffed him in the backseat of our truck, bought gas, dumped Josh in a field and set his body on fire. The killer went home took a shower and went to see a movie.

I testified before the Senate last July, 2015 and told this story. Nothing has been done about it. People are dying as we speak from illegal alien criminals. Does anybody here know the number of people whom have died or been raped or brutalized since then? That answer is no. Why? Because the Government has no clue who is here or what their intent is in being here. I see this American government scrambling over themselves to pretend to care about American Families, and instead to give away every bit of it to people whom have broken your laws on how to enter this country. Then on to break other laws, now to having sanctuary cities, teaching them how to grab a piece of America unlawfully, and at the expense of American families.

I am stunned, shocked, saddened that we are even having this discussion. When will you act on this? Maybe it will take the loss of your child. Which child or grandchild from your own family, would you select to die, to finally Act on this issue?
