

AMENDMENT IN THE NATURE OF A SUBSTITUTE
TO H. RES. 111
OFFERED BY MR. GOODLATTE OF VIRGINIA

Strike all after the resolved clause and insert the following:

1 That the Attorney General of the United States is
2 directed to transmit, to the extent that such information
3 is in the possession of the Attorney General, (in a manner
4 appropriate to classified information, if the Attorney Gen-
5 eral determines appropriate) to the House of Representa-
6 tives, not later than 14 days after the date of the adoption
7 of this resolution, copies of any document, record, memo,
8 correspondence, or other communication of the Depart-
9 ment of Justice, including the Office of Legal Counsel, or
10 any portion of any such communication, that refers or re-
11 lates to—

12 (1) any criminal or counterintelligence inves-
13 tigation targeting President Donald J. Trump, Na-
14 tional Security Advisor Michael Flynn, Paul
15 Manafort, Carter Page, Roger Stone, or any em-
16 ployee of the Executive Office of the President;

17 (2) any investment by any foreign government
18 or agent of a foreign government in any entity

1 owned in whole or in part by President Donald J.
2 Trump;

3 (3) President Trump's proposal to maintain an
4 interest in his business holdings, while turning over
5 day-to-day operation of those interests to his sons
6 Donald J. Trump, Jr., and Eric Trump;

7 (4) President Trump's plan to donate the prof-
8 its of any foreign governments' use of his hotels to
9 the United States Treasury, including the decision
10 to exclude other payments by foreign governments to
11 any other business holdings of the Trump Organiza-
12 tion from that arrangement;

13 (5) the Foreign Emoluments Clause (U.S.
14 Const. art. I, §9, cl. 8) as it may pertain to Presi-
15 dent Donald J. Trump or any employee of the Exec-
16 utive Office of the President; and

17 (6) any of the following Federal statutes gov-
18 erning conflicts of interest as they may pertain to
19 President Donald J. Trump or any employee of the
20 Executive Office of the President:

21 (A) The Ethics in Government Act of 1978
22 (5 U.S.C. app. 101 et seq.).

23 (B) Section 3110 of title 5, United States
24 Code (concerning employment of relatives).

1 (C) Section 7342 of title 5, United States
2 Code (concerning receipt and disposition of for-
3 eign gifts).

4 (D) Section 7353 of title 5, United States
5 Code (concerning gifts to federal employees).

6 (E) Section 201 of title 18, United States
7 Code (prohibiting bribery of public officials).

8 (F) Section 208 of title 18, United States
9 Code (prohibiting participation by government
10 officials in matters affecting their personal fi-
11 nancial interest).

12 (G) Section 211 of title 18, United States
13 Code (prohibiting acceptance or solicitation to
14 obtain appointive public office).

15 (H) Section 219 of title 18, United States
16 Code (prohibiting federal officers and employees
17 from acting as agents of foreign principals).

18 (I) Section 1905 of title 18, United States
19 Code (prohibiting disclosure of confidential in-
20 formation).
