I am writing on behalf of Intellectual Property Owners Association (IPO) in support of the proposal for Reform of the Copyright Office ("Reform Proposal") and to urge you to implement the Reform Proposal as soon possible.

analyzing current intellectual property issues; providing information and educational services; and disseminating information to the general public on the importance of intellectual property rights.

IPO generally supports the view expressed by Register Pallante that the Copyright Office needs to re-envision most of its services, including how customers register claims, submit deposits, record documents, share data, and access expert resources.”¹ IPO is pleased that the Copyright Office’s IT Plan seeks to modernize its systems in a way that more effectively and efficiently serves the needs of authors, users of copyrighted works, and the general public. We also appreciate that the IT Plan is targeted to meet the current and future needs of creators and the general public by minimizing costly infrastructure needs, embracing cloud services, and utilizing mobile technologies. Modernizing the Copyright Office IT system and giving the Office control over its IT system is essential to an effective and efficient twenty-first century Copyright Office.

IPO also hopes that the upgrades to the Copyright Office systems will be done at the direction of the Copyright Office itself and not through the Library of Congress. Appropriated funds for an upgrade should be separate and distinct from any funds that Congress appropriates to the Library of Congress for its technology systems. The Copyright Office should have full control over the decisions about how that money is used, including making its own IT decisions, selecting its own vendors, and making its own contracting and procurement decisions.

We appreciate your support for funding as soon as feasible for a new and improved Copyright Office that is essential to copyright as the engine of free expression and a significant building block of the national economy. Please let us know if IPO can be helpful as you decide how to proceed.
