Dear Attorney General Sessions, Deputy Attorney General Rosenstein, and Director Wray:

Earlier this year, media reports indicated that in 2016, the FBI used information contained in a controversial dossier to justify a FISA warrant against Carter Page, a onetime advisor to President Trump's presidential campaign. Former FBI Director James Comey also apparently cited the dossier "as one of the sources of information the bureau has used to bolster its investigation." Recent revelations make clear that the dossier was "opposition research" funded by the Democratic National Committee, and the Clinton campaign.

As you know, this Committee has repeatedly requested information from the Justice Department pertaining to the 2016 presidential election, the FBI's investigation of former Secretary Clinton's email server, and the actions of former Director Comey and senior FBI officials and investigators in connection with that investigation. This Committee has also requested that the Department appoint a second Special Counsel to investigate these matters.⁴ The Department has not done so to date. Consequently, in October, this Committee initiated a joint investigation of these matters with the Committee on Oversight and Government Reform.⁵

As the principal Committee of jurisdiction over the FBI and DOJ, it is imperative that this Committee conduct oversight over the decision to seek a FISA warrant based, at least in part, on
